



Corwin Hardham Memorial Scholarship

2023 Scholarship Application

The Gorge Technology Alliance (GTA) is offering one \$2,000 scholarship to a qualified graduating high school senior in Hood River, Wasco, Sherman, Skamania, or Klickitat County. The student must be graduating from high school or home school or receiving a GED in the spring/summer of 2023.

GETTING STARTED:

- Submit all information on 8 ½ x 11" paper or via email. Please staple all application materials together if printed.
- When submitted, this application becomes the property of the GTA.
- Award recipient will be sent a notification letter by June 2023. The scholarship will be payable in the 2023 fall term upon enrollment on a half-time or more schedule at an accredited post-secondary institution. The student will be required to submit documentation showing proof of enrollment, including his/her name, the name of the school, and the number of credit hours he/she is taking. Upon receiving the required documentation, payment will be made directly to the accredited post-secondary institution.

THE FOLLOWING CRITERIA WILL BE USED TO DETERMINE ELIGIBILITY:

- Financial need
- STEM (Science, Technology, Engineering, Mathematics) activities past/present, including intention to pursue a STEM related degree. Art-oriented STEAM projects are also of interest.
- Academic merit

THESE ITEMS MUST BE INCLUDED IN YOUR APPLICATION PACKET:

- Application form. Remember to sign and date!
- Attach a one (1) page essay (maximum) about yourself using 11 pt. font, single spaced, and typed. Consider including your educational/career goals, including STEM degree aspirations, community activities, and financial conditions or life circumstances that contribute to your need for a scholarship.
- Two letters of recommendation (only) addressed to the Gorge Technology Alliance. Letters must include signatures, contact information, and disclosure of the relationship, such as employer, school counselor, volunteer coordinator, or teacher. Letters cannot be from a relative.
- Attach a list of activities (no more than one (1) page) – high school, community, and organizational activities in which you have participated during the past two years. Include recognition or achievements you have attained (scholarships, honors, awards, etc.). Please remember to note all STEM-related activities.
- Attach proof that you have calculated your Estimated Family Contribution. Acceptable proof is the confirmation page from your **FAFSA for 2023-24**. Or, you may attach the EFC calculator estimate from CollegeBoard.org. Be aware that receiving a scholarship may affect your Federal Financial Aid award.
- Attach high-school transcript (or equivalent if home school student or GED recipient; unofficial copies accepted).

INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.

Your completed application packet must reach the GTA by **Monday, February 27, 2023 at 5:00 p.m.**
